Background Information:

The HRC appointed Susan Leuty as the regional liaison.

The congregation has followed due process by receiving a request from 10% of full members for a congregational meeting, by completing their congregational profiles which were received by the Covenant Commission, by giving notice to the minister and congregation about the congregational meeting. Susan Leuty attended the congregational meeting held on November 3, 2019. Earlier, Diane and Susan attended an Official Board meeting on September 18 to explain the process.

Onus is off the incumbent.

New Title to keep clear from others with the name 'Covenant' is: Collegiality Agreement between Incumbent and Non-incumbent Ministers.
