Welcome and Constitute Meeting: Ann Harbridge welcomed all and constituted the meeting in the name of Jesus Christ for all business that rightfully comes before it.

Acknowledging the Land: Ann Harbridge

I live in the southwest corner of Simcoe County, which is on the traditional territory of the Anishnaabeg people. The Anishnaabeg include the Ojibwe, Odawa and Pottawatomi nations, collectively known as the Three Fires Confederacy. We are dedicated to honouring the Indigenous history and culture and committed to moving forward in the spirit of reconciliation and respect with all First Nation, Metis and Inuit people.

Opening Worship: Kate Crawford led a short meditation using the singing bowl.

Opening Agreements:

Welcome Cheryl-Ann Stadelbauer-Sampa, Executive minister to the meeting.

Corresponding members:

The Covenant Commission of Western Ontario Waterways Regional Council **agree** to receive representatives Lynn McRuer and Margaret Fleury from Glen Morris United Church as corresponding members to this meeting.

Approval of Agenda:

The Covenant Commission of Western Ontario Waterways Regional Council **agree** on the agenda.

Approval of Previous Minutes:

The Covenant Commission of Western Ontario Waterways Regional Council **agree to** approve the minutes of May 7, 2020 and June 5, 2020 as circulated.

Business Arising

1. Massie

Cheryl-Ann Stadelbauer-Sampa joined the Commission for this discussion.

- a. Another letter received;
- b. Decision needs to be made about how to proceed due to non-compliance.

Cheryl-Ann Stadelbauer-Sampa provided an overview and history of the situation. Cheryl-Ann then left the meeting.

The commission welcomed the Glen Morris United Church representatives, and paused discussion of the Massie situation. Thom McDonough & Judy Chalmers joined the meeting.

Glen Morris United Church representatives Lynn McRuer and Margaret Fleury outlined plans for the addition to the church. They noted the church has no qualms about repaying the mortgage and are quite confident they will be able to meet the payments. The church has been looking at different fundraising possibilities due to the pandemic, and are getting back on track with fundraising efforts. Lynn and Margaret left the meeting.

MOTION Thom McDonough / Norm Eygenraam

Western Ontario Waterways Covenant Commission approves Phase 3 of the Glen Morris United Church building plan and the financial plan they have developed for it. The Commission expresses their thanks to Glen Morris United Church for their ongoing work and enthusiasm.

CARRIED

The commission returned to their discussion of the Massie situation. A fulsome discussion ensued; addressing how to proceed, how to proceed with grace, the history of this continuing issue and the perceptions of the situation within the community of faith, the Covenant Commission and particularly surrounding communities of faith in the area. Ann Harbridge asked all commission members for their opinion.

Possible ways forward:

- Give the congregation the option of leaving the United Church of Canada (implications re: building/funds)
- Conduct a congregational review
- Covenant Commission take over as board

The Commission determined that they were not prepared to make a motion at today's meeting, and felt a meeting devoted to this issue only would be beneficial. It was agreed that including Cheryl-Ann Stadelbauer-Sampa, the previous minister at Massie, and Margaret Krauter, the current pastoral charge supervisor, in the conversation would be helpful.

John Neff will advise the Massie community of faith; acknowledging that the Covenant Commission is taking the situation under consideration and will be reviewing.

It was agreed to hold a zoom meeting on June 25th to further discuss the Massie situation.

Thom McDonough left the meeting.
