Staff Reports:

<u>Diane Matheson-Jimenez</u>: Social Justice – Wesley Urban Ministries has announced that the COVID-19 outbreak has now been resolved.

- SJNOR: Focusing on Guaranteed Basic Income. A rep from WOW M&D is needed for this network. SJNOR meets 3-4 times a year and meeting expenses are covered by the Network.

<u>Kathy Douglas</u>: Camps: All 11 camps are meeting weekly via zoom. There is a sense that they should wait for the Ministry of Health to say camps can't run this summer due to COVID-19. As Corporations, camps are eligible for the government loans available. More information regarding the camps gathering with the Think Muskoka consultants will be forthcoming.

Youth Ministry: Three webinars are available: 1. Duty of Care and safety on digital platforms. 2. Offering Pastoral Care and 3. Youth ministry. Email Kathy to get links for these webinars.

Mental Health: This initiative is on hold.

<u>UCW: Joyce Osborne</u>: 1. May 2<sup>nd</sup> AGM was cancelled and rescheduled for October. 2. UCW could become a Community of Faith and as such could have official representation at the Regional Council.

<u>Mission Support Applicants</u>: There were three applicants who we have not heard back from. Deanne agreed to write a second letter and circulate it to the group.
