- **2.** Update from Pastoral Relations Minister, Diane Blanchard: GS-58, Extension of Temporary Amendment of Bylaws: extended to the end of December governing bodies can make pastoral relations decisions, with consultation.
 - New Hamburg are calling a minister by Zoom on Sunday. The balloting process that needs to be used is by Zoom voting.
- **3.** Update from representative to Executive: Micol Cottrell: preparing for regional meeting. We have 30 minutes on agenda for United Fresh Start. Resuming in-person worship information is in last newsletter. Tri-regional meeting is today at 2pm around staffing. Regular meeting tomorrow re grants, money.

7. MOTION that the Human Resources Commission of Western Ontario Waterways Regional Council grant Alex Jebson a Sacrament License for Blyth and Brussel United Churches.

- **8.** Calvary United Church, St. Jacob's CDM Positions on staff. We asked for position descriptions. A significant change from the previous position of a DLM. CDMs are not the same as DLMs with training. CDMs are baptized lay people, don't have to be United Church and can be full-time positions. Salaries not regulated by UCC. Tabled discussion. Commission members should review the CDM handbook and categorization chart for next meeting.
- 9. Ballinafad United Church Change in Pastoral Relations for Felicia Urbanski: amalgamating with Erin United Church. Minister Urbanski will stay with both points. Unsure what Ballinafad will financially contribute unless the church is sold. Would normally terminate both pastoral relationships and then, 1) could call Felicia Urbanski, or 2) submit a position description and start a new one. Ending of relationship in November letter sent to Felicia Urbanski. Many pieces are needed in this change. May be change in hours needed from half-time. Hope to sell building, reality may be that they need to let Felicia go.

A liaison needs to be appointed to Erin United Church with this request being made. Diane Blanchard will send invitations.

MOTION that the Human Resources Commission of Western Ontario Waterways Regional Council accede to the request of change in pastoral relationship with Ballinafad United Church and Felicia Urbanski effective November 30, 2020.

10. Former DLM relicensing – a retired DLM, Doug Brown, requested a re-licensing of a Sacramental License.

11. Policies/guidelines for LLWLs and those providing Pulpit Supply who may be leading worship in multiple pastoral charges during COVID-19.

Advised to have 14 days break between in-person supply from one community to another. Should this be a limitation? The LLWL Task Group looked at this.

MOTION that the Human Resources Commission of Western Ontario Waterways Regional Council highly recommend that LLWLs and Pulpit Supply leave a 14-day period (one Sunday) in between in-person supply from one community of faith to another.
