## Acknowledging the Land: Judy Chalmers

Judy shared the land acknowledgement that was developed with the help of M'Wikwedong Indigenous Friendship Centre and the Chippewas of Nawash and adopted in February 2021 by Grey County councillors

"We acknowledge with respect, the history, spirituality, and culture of the Anishiaabek, Six Nations of the Grand River, Haudenosaunee, and Wendat-Wyandot-Wyandotte peoples on whose traditional territories we gather and whose ancestors signed treaties with our ancestors. We recognize also, the Metis and Inuit whose ancestors shared this land and these waters. May we all, as Treaty People, live with respect on this land, and live in peace and friendship with all its diverse peoples."

1. Dundalk UC – Approval of Phase 2 and use of \$150,000 from restricted funds (sale of manse). David Shearman is working with Dundalk on this as PCS and is well up on the details.

## **MOTION** Norm Eygenraam / Judy Chalmers

That the Covenant Commission of Western Ontario Waterways Regional Council approves Dundalk UC's phase 2 renovation project and the use of \$150,000 of the restricted capital (sale of manse). Manse proceeds were \$407,000. This leaves \$257,000 to be invested according to the Regional Council property policy. **CARRIED** 

2. Port Elgin UC – Request for adherents to be on governing body.

### **MOTION** Marg Bakker / Norm Eygenraam

That the Covenant Commission of Western Ontario Waterways Regional Council approve the request of Port Elgin United Church to fill the positions of secretary and treasurer on the governing body with not full members as corresponding members.

From The Manual

B.7.3 Membership of the Governing Body, B.7.3.1 General

The governing body has the following members:

a) the full members of the congregation elected by the congregation or pastoral charge;

Exception: There is one exception to the requirement in paragraphs (a) and (e) above for governing body members to be full members of the congregation: People who are not full members may be elected in special circumstances with the regional council's approval.

### 3. Disbandment of Holland Centre United Church

The Covenant Commission previously approved the intent to disband, sale of the building, and the disposition of assets. The building is now sold, assets received, and disposition completed. John have now regularized the process through 3 regional councils. We don't set disbandment date until all the assets etc.

That the Covenant Commission of Western Ontario Waterways Regional Council disbands the Holland Centre United Church effective as of today (March 11, 2021) and thanks them for their ministry and witness. **CARRIED** 

4. Zion United Church, Rostock - Request for name change

That the Covenant Commission of Western Ontario Waterways Regional Council agrees with the name change of Sebringville Pastoral Charge, Zion United Church to Rostock Pastoral Charge, Rostock: Zion United Church as per their request. **CARRIED** 

John noted trying to regularize names, so any name changes reflect geographic location. Sebringville closed, so Zion wanted to drop that part of the name.

5. Mount Hope UC - Demolition of building and transfer of property to municipal cemetery

### **MOTION** Norm Eygenraam / Sandy Loomis

That the Covenant Commission of Western Ontario Waterways Regional Council accept the proposal of the board and trustees of Mount Hope United Church for the demolition of the church building by Faust Construction and the transfer of the cemetery and church property, the legal description of which is the west corner of 10<sup>th</sup> side road and the 2<sup>nd</sup> concession of Arran Township, and the municipal address of which is 199 side road 10 south, to the Municipality of Arran-Elderslie for future and forever care.

Any residual funds to be dispersed according to WOW Regional Council property policy.
